

Rental Requirements

Income Requirements:

- Applicants must have a current, verifiable gross income of three times (3), the amount of the rental rate for the unit for which the applicant applies for.
- Applicants must provide paycheck stubs as proof of income. If self-employed applicant to provide the most current income tax returns, and/or additional supporting documentation.

Credit History:

- A credit check and unlawful detainer registry check will be run on all applicants.
- Applicants must have; good credit.

References:

• Applicants must have good rental history, and employment references.

Additional Requirements:

- Applicants must provide valid photo identification.
- Initials funds for move-in (security/holding deposit and the first months' rent) must be paid with a cashier's check or money order.

Security Deposits:

- Security deposits are one and one half of the monthly rent for homes with no pets.
- Security deposits are two times the monthly rent for homes with pets.

<u>Please Note!</u> There is a \$30.00 application screening fee per applicant, payable in cash/money order/cashier's check/Venmo. The \$30.00 fee is non-refundable fee. Each applicant over 18 years of age is required to complete an application.

NOTICE REGARDING CALIFORNIA INVESTIGATIVE CONSUMER REPORTING AGENCIES ACT

☐ Landlord does <u>not</u> intend to request an investigative consumer report regarding the Applicant.

Unless the box above is checked, Landlord intends to request an investigative consumer report regarding the Applicant's character, general reputation, personal characteristics, and mode of living. Under Section 1786.22 of the California Civil Code, the files maintained on you by the investigative consumer agency shall be made available to you during business hours and on reasonable notice, provided you furnish proper identification, as follows: (1) You may appear at the investigative consumer reporting agency identified below in person, (2) you may make a written request for copies to be sent by certified mail to a specified addressee, or (3) you may make a written request for a summary of the file to be provided over the telephone. The agency may charge a fee, not to exceed the actual duplication costs, if you request a copy of your file. The agency is required to have personnel available to explain your file to you, and the agency must explain to you any coded information appearing in your file. If you appear in person, a person of your choice may accompany you, provided that this person furnishes proper identification. If you are accompanied by a person of your choosing, the agency may require you to furnish a written statement granting permission to the investigative consumer reporting agency to discuss your file in the other person's presence.
